All matters relating to county health services, including, in particular county health facilities and pharmacies, ambulance services, promotion of primary health care, licensing and control of undertakings that sell food to the public, cemeteries, funeral parlours and crematoria.

The committee is also responsible for:

1. Oversight over the county executive committee, approval of plans and policies for the management and exploitation of county resources
2. Development and management of its infrastructure and institutions

2.0 Report of the Committee on the Kericho County Health Services amendment bill 2021

CLAUSE 6

THAT, Clause 6 sub Clause 1 be amended by deleting the word appoint after the word “and” replacing with the word recruit.

CLAUSE 11

THAT, Clause 11 be amended by adding the following new paragraph “h” immediately after paragraph “g”

(h)The county Executive committee member shall, while appointing the members of the committee, ensure gender equity representation of persons living with disability, youth and marginalized groups

CLAUSE 14

THAT, Clause 14 paragraph b sub paragraph iv be amended by deleting the words’ without permission of the chairperson immediately after “the” and replacing with the words ‘without notice’

CLAUSE 17

THAT, the following new paragraph (k) be inserted immediately after paragraph (j)

‘responsive to emergencies ‘

CLAUSE 44

THAT, Clause 44 sub Clause (2) paragraph (m) be amended by adding the words ‘and County assembly’ immediately after the word “treasury”
