PRAYERS

The Speaker (Hon. Dr. Patrick Mutai): Good afternoon Honorable Members to today's special sitting being 16th December 2022. Order of business today, Clerk!

PAPERS

The Speaker (Hon. Dr. Patrick Mutai): The Honorable Dr. Namaan Rop please lay the paper and inform the House about what it is all about and I think it was part of today's business.

Hon. Dr. Namaan Rop (Member for Soin Ward): Thank you Mr. Speaker, I would like to give a status report on the ad hoc committee on Kabianga Tea Farm.

The committee held its first sitting on 14th December 2022 at Ciala Resort in which the election was conducted and Dr. Namaan Rop became the Chairperson and Hon. Hon. Paul Chirchir (Member for Kapsoit Ward): Thank you. Mr. Speaker I also beg to give a notice of motion of the following motion, the committee of Selection, report on the placement of members to various committees of the County Assembly submitted pursuant to Standing Order no. 167.

The Speaker (Hon. Dr. Patrick Mutai): Thank you very much. Next order!

**MOTION BY MAJORITY LEADER- HON. PAUL
CHIRCHIR**

The Speaker (Hon. Dr. Patrick Mutai): The honorable Majority this is your first notice, you read the last page that is summary of the report.

Hon. Paul Chirchir (Member for Kapsoit Ward): Thank you Mr. Speaker, so I stand guided I will do exactly that. That there are annexures there, I will go the observation.

The Committee Observations

Pursuant to section 10 (2) of the Public Appointment (County Assemblies Approval) Act No. 5 of 2017, a nominating authority shall not resubmit the name of a candidate whose nomination has been rejected by the county Assembly unless the circumstances relied on for the rejection of the appointment of the candidate did not exist or ceased to exist at the time of rejecting the nomination of the candidate.

1. The committee observed that the appointing authority adhered to the recommendation of this House by regularizing the nomination process of the said nominee by submitting the selection panel to this house for approval.
2. The selection panel for recruitment of the county secretary /Head of public Service having been approved by this house the process for recruitment of the County Secretary thereafter stood regularized.
3. His Excellency the governor via his letter dated 7th December 2022 confirmed to the committee that the said selection panel was the same that conducted the recruitment of the said nominee.
4. This honorable House adopted the report by the committee on appointment on 2nd November 2022 where it found the nominee suitable for appointment to the position of county secretary /head of public service.

Mr. Speaker Sir, the Committee Recommendations.

1. The committee having confirmed that the process of recruitment of the county secretary / head of County Public Service has been regularized and that the House had already found him suitable for the said position, there was no need to subject the same nominee to another approval hearing exercise.
2. The committee therefore recommends Dr. Wesley K. Bor for the appointment to the position of County Secretary and Head County Public Service. The motion will be seconded by honorable Cheruiyot Bett.

(Hon. Cheruiyot Bett bows in secondment)

(Question proposed).

The Speaker (Hon. Dr. Patrick Mutai): I will give only to one person to make a comment, yes Hon.Hezron Ngetich.

Hon. Hezron Ngetich (Member for Chilchilla Ward): Thank you Hon. Speaker for this opportunity you have given me so that I can rise and support the motion by the Appointment committee on the appointment and approval of one Dr. Wesley K. Bor. First, I want to echo what the committee did in regularizing the appointment of one Dr. Wesley Bor because initially there were steps which were missed but it has been regularized. However the nominee had appeared before the committee on appointment and went through vetting. During his vetting the nominee demonstrated ability and in the eyes of the public, he is suitable. Appointing Dr. Wesley Bor will be a plus because the coordination of government business will be on his desk and he will fast track all the executive orders by the Governor. I urge this House to support the motion so that the nominee will be sworn in and the work will start immediately. Thank you Mr. Speaker, I support the nomination of one Dr. Wesley K. Bor.

The Speaker (Hon. Dr. Patrick Mutai): Thank you very much Hon. Hezron, Hon. Philip! Stick to a minute.

Hon. Philip Rono (Member for Kamasian Ward): Thank you very much for the opportunity you have given me on behalf of the people of Kamasian Ward. I would like to urge the House to approve the candidate. He is a person who is known to me for a long time and he has actually worked hard to reach the position that he is in right now. I confirm to this House that we will not regret by appointing the said person to the County Public Service. Thank you very much. I want to thank my colleagues because from the look of things, it seems they are going to approve without any comments. Thank you.

The Speaker (Hon. Dr. Patrick Mutai): Thank you. The mover of the motion, please reply!

Hon. Paul Chirchir (Member for Kapsoit Ward): Thank you. I want to thank the Honorable members this afternoon for supporting the submission and approval of Dr. Wesley Bor. As demonstrated during vetting, the nominee is suitable for the task and I wish to thank members for supporting the approval of Dr. Wesley Bor and we wish him the very best as he begins his duty in Kericho.

Mandate of the Committee

Standing Order 167 of the Kericho County Assembly Standing Orders mandates the Committee on Selection to nominate members to serve in committees safe for the membership of Selection the Assembly Business Committee and the Committee on Appointments. The committee placed members in various committees in October 2022 and tabled a report that was adopted by the House. However there was a change in the County Assembly leadership that affected the

The Nomination Process

In the reconstitution of the committees the committee adopted consultation as the main guiding principle where members who felt disadvantaged were invited before the committee to explain their dissatisfaction additionally members who agreed to relinquish their committees membership were consulted for consensus. The committee was also guided by the constitution, Standing Orders and the County Government Act of 2012 on the need for gender and regional balance, preference by honourable members, membership and responsibilities in other committees and in the House leadership.

Committee Observations

The committee observed the following;

1. That a few members had been disadvantaged in the first placement of members to various Committees and hence there was need to balance the membership.
2. The change in house leadership led to the changes of certain committees whose membership is determined by the House leadership.
3. That there were changes done through local arrangements that were not reflected in the first report of the committee hence the need to regularize the same.
4. That the Standing Orders pegs the number of sectorial committees assigned to a member to a maximum of three.
5. That those members without responsibilities be given priority.

A few committees does not have, so we expect that members of the various committees that are affected to retreat and conduct their own in house election for the chairpersons and the vice chairpersons so that we communicate to this house the positions of chairpersons and vice chairpersons respectively.
