**PRAYERS**

**The Speaker (Hon. Dr. Patrick Mutai):** Good afternoon honorable members. First I request the Clerk to count and confirm if we have the quorum.

*(Members present in the House counted)*

**The Speaker (Hon. Dr. Patrick Mutai):** Serjeant-at-Arms, kindly ring the bell for members outside to come in. Since the Chief Whip is not present, Majority Leader kindly go and call the members.

*(Quorum bell rung)*

**The Speaker (Hon. Dr. Patrick Mutai):** Honorable members this is a House of rules and procedures and it's important that we always have quorum. Majority Leader I direct that you consult with the Chief Whip and inform the honorable members the importance of attending the

sessions. Remember that we are always live on our Face book page and therefore it's important for members to take their work seriously.

### **COMMUNICATION FROM THE CHAIR**

**The Speaker (Hon. Dr. Patrick Mutai):** Honorable members, in our morning session this House approved two honorable members to the County Assembly Service Board (CASB), that is Hon. Paul Chirchir and Hon. Anita Mibei. These two members will be sworn in today immediately after this session.

Secondly, this is a communication on the composition of car loan and mortgage committee, regulation 6(1) of the Public Finance Management, Kericho County Assembly Car Loan Scheme Fund of 2014 establishes the Car Loan committee which consists of the following;

- a. The Leader of Majority party who shall be the chairperson.
- b. The Leader of Minority party who shall be the vice chairperson
- c. The Whip of the majority party and one member of the county assembly elected by the members of the county assembly

Further, regulation 6(1) of the Kericho County Assembly Member's Mortgage Scheme Fund, 2014 which consists of the following;

- a. The leader of majority party who shall be the chairperson.
- b. The leader of minority party who shall be the vice chairperson
- c. The whip of the majority party and one member of the county assembly elected by the members of the county assembly responsible for housing

Please note the roles of car loan and Mortgage committee is to consider and approve car loan and mortgage for honorable members and staff as per the laid down rules in the said regulations. The quorum for any of this meeting is the chairperson and three other members of the committee.

Kindly note that this assembly does not have the minority leader hence once the committee is fully constituted the members shall elect a vice chairperson. From the said regulations this house is required to elect two other members who shall serve in the said committee. I therefore communicate that the Leader of Majority in consultation with the honorable members to forward two names to the office of the speaker so that the same can be approved by the assembly at the date that shall be set by the house business committee.
