STATEMENT BY HONORABLE PAUL CHIRCHIR

Hon. Paul Chirchir (Member for Kapsoit Ward): Thank you Hon. Speaker for giving me an opportunity to table the following statement;

Pursuant to Section 9 of the County Governments Act, 2012 and the Kericho County Assembly Standing Orders no. 48(1), I wish to seek a statement from the Committee on Agriculture, Livestock and Fisheries on the following issues;

- a) The number of Cooperative Societies in Kericho County
- b) The number of Dairy Cooperative Societies in Kericho County
- c) The average number of liters of milk collected from farmers by the Dairy Cooperatives
 Societies per day

The Speaker (Hon. Dr. Patrick Mutai): Thank you Hon. Paul Chirchir, I now invite the Chairperson for Agriculture, Livestock and Fisheries Committee to come and tell us how many days he requires to come and give us the response.

Hon. Julius Siele (Chairperson Agriculture, Livestock and Fisheries Committee, Member for Waldai Ward): Thank you Mr. Speaker for giving me this opportunity. First, I want to thank my electorates who gave me the mandate to represent them in the third County Assembly of Kericho.

STATEMENT BY HONOURABLE MATHEW KORIR

Hon. Mathew Korir (Member for Chaik Ward): Thank you very much Mr. Speaker for this opportunity;

Pursuant to Section 9 of the County Government Act, 2012 and the Kericho County Assembly Standing Order no. 48(1), I wish to seek a statement from the Committee on Agriculture, Livestock and Fisheries on the following issues;

- a) The number of machines being used by Multinational Companies in Kericho County
- b) The number of employees before the introduction of machines and the number retained to work as tea pluckers in the said Multinational Companies
- c) Total amount paid in terms of rates to Kericho County
- d) The current cost of hand plucking per kilo verses the cost incurred using the machine
- e) The risks arising as a result of using machines and measures to mitigate the risk

The Speaker (Hon. Dr. Patrick Mutai): Thank you Hon. Mathew Korir, I want to make a clarification from the first statement that was raised by Hon. Paul Chirchir, on the matter that touches on the Cooperative Societies, from the issues raised in the statement I think it should be on the Committee on Cooperative Management, Tourism and Wildlife. Hon. Mathew Korir (Member for Chaik Ward): Point of Information!

Hon. Mathew Korir (Member for Chaik Ward): Mr. Speaker on the statement raised by Hon. Paul Chirchir, I think it affects two Committees because Dairy Farming falls under the committee on Agriculture, Livestock and Fisheries and Cooperative Societies falls under the Committee on Cooperative Management, Tourism and Wildlife, so in my opinion the two committees should work together and give us answers on the same. Thank you.

The Speaker (Hon. Dr. Patrick Mutai): Okay, Hon. Matthew I am not disputing this but the statement is seeking answers from the committee on Agriculture, Livestock and Fisheries, the Hon. Paul Chirchir, please clarify this.

Hon. Paul Chirchir (Member for Kapsoit Ward): Thank you very much Mr. Speaker, in your wisdom I have seen that you intend to ask the two committees, that is the committee on Cooperative Management, Tourism and Wildlife and the Committee on Agriculture, Livestock and Fisheries to sit together and respond to the statement that I have raised and I think it's wise that the two Committees sit together. Thank you.

The Speaker (Hon. Dr. Patrick Mutai): Thank you Hon. Paul Chirchir, this is a matter that touches on both the Committees on Agriculture and Cooperatives and also from here it will go to CEC Agriculture, Livestock and Fisheries and Cooperatives fall under that docket. I therefore direct that the two committees affected to dispense on the matter within the next fourteen days. I don't think the chairperson for Cooperative Management, Tourism and Wildlife Committee need to comment because the Chairperson for Agriculture has already done so. On whether you will sit together or do it differently in your respective committees is up to you. I hereby commit this statement to the two committees.
