Hon. Noella Opile (Nominated Member representing Minority Group): Thank you Mr.

Speaker Sir, I will read that the Kericho County Finance Bill 2022, Second Reading. Memorandum of objects and reasons.

The object of this Bill is to impose or vary various cess and other charges for various services provided by the county.

Part I of the Bill provides for preliminary provisions.

Part II of the Bill provides for the charges, licenses, plot or house rent, cess or market fee to be paid to the county for services. It also provides for amendment to the Act.

Part III of the Bill provides for the appointment and duties of an agent in respect to collection of revenue for the county. It also provides for the mode of payment of revenue to the county.

Part IV of this Bill provides for the general penalty for the offences committed under this Bill. It provides for the offences carried out by the staff of county and the penalty of the offenses.

Part V of this Bill provides of miscellaneous, savings and cessation of rates of fees, charges, licenses, cess or rent applicable before the commencement of this Bill.

I call up on the seconder Hon. Rogony. Thank you.

The Chairman (Hon. Erick Bett, Member for Kipchebor Ward): Thank you so much members, I now invite the clerk to give us opening remarks.

#### Part I

That clause 2 (1) of the Bill be amended by deleting the words "Ainamoi Town" 'from "Zone B" and be further amended by adding the words Ainamoi town in "Zone C".

#### Part II

That part II of the Bill on stock movement permit be amended by deleting the whole provisions on stock local movement permits.

That part II of the Bill on storage charge on impounded animals' storage charge per day be amended by deleting the figures "120" and replacing with the figures "50".

That part II of the Bill on certificate for keeping animals in urban areas be amended by deleting the figures "200" and replacing with the figures "500".

#### Part III

That part III of the Bill be amended by deleting the figures "2,300" on salon and barber shop and replacing with the figures "2,000" and be further amended by deleting the figures "3,500", "3,600" and "2.400" on blacksmith /workshop, garage / workshop and open air garage and replacing with figures "2,500", "2,500" and "2,000" respectively.

#### Part IX

Part IX of the Bill be amended by deleting the figures "300" on monthly stickers on Boda boda (Kericho town /Zone A) and replacing with the figures "200" and be further amended by deleting the figures "1,300" on boda boda ( half year ) and replacing with the figures "1,000".

That Part IX of the Bill be amended by deleting the figures "2,500" on Boda boda (Annual) and replacing with the figures "1,900".

The Chairman (Hon. Erick Bett, Member for Kipchebor Ward): Thank you so much, I now call upon the Chairman Finance and Economic Planning to lead us in those amendments, or a member who will stand in for the Chairman Finance and Economic Planning.

Hon. Kiprotich Rogony (Member for Sigowet Ward, Standing in for Chairperson Finance and Economic Planning): Thank you Chairman.

The Chairman (Hon. Erick Bett, Deputy Speaker, and Member for Kipchebor Ward): We are giving you a chance to justify those amendments. You need to highlight those changes that the Clerk has just read so that members can react and give their contributions.

Hon. Kiprotich Rogony (Member for Sigowet Ward, Standing in for Chairperson Finance and Economic Planning): Thank you Chairman. Am standing in for the chairman and am a member of the committee. It is true the changes in this Finance Bill in part I if you can check the removal of Ainamoi town from "Zone B" to" Zone C" and this might have been necessitated by or the committee felt that the charges were way too high and doing the public participation ,majority of the people requested the changes. Part II, this is now new and we felt that in other counties traders are charged and when we come to our county we normally don't. We introduced this particular part. So this is an introduction and we feel we were losing so much of our revenues if we didn't use this particular part.

#### Part II

That part II of the Bill on stock movement permit be amended by deleting the whole provision on stock local movement permits. Again this is new; we introduced this because quite often we have not been getting revenue out of this and this is a revenue stream that could earn this county the much revenue needed. Chairman as a committee during the public participation part III, you will see this is a reduction on the initial charges levied on these businesses. The committee considered during the public participation. This country has been going through hard economic times lately and most of these traders felt they are being overcharged as many of them comes from urban centers they have an opportunity to pay their Bills and what have you. So Mr.,

chairman I am in total support and I want to commend the work of the committee on this Finance Bill and I support the review and the deductions in these arears that we've touched so that we make it affordable for the business men and women in our urban centres. So I support the report. Thank you.

## 2.0 The Legal framework on Kericho County Annual Development Plan for FY 2023/2024

**Mr. Speaker Sir**, the Kericho County Annual Development Plan, 2023/2024 was submitted to the County Assembly on 31st August 2022 and the same was committed to the Budget and Appropriation Committee.

Section 126 of the Public Finance Management Act, 2012 states that:

- (1) Every county government shall prepare a development plan in accordance with Article 220(2) of the Constitution, that includes—
- (a) Strategic priorities for the medium term that reflect the county government's priorities and plans;
- (b) A description of how the county government is responding to changes in the financial and economic environment;
- (c) Programmes to be delivered with details for each programme of—
  - (i) The strategic priorities to which the programme will contribute;
  - (ii) The services or goods to be provided;
  - (iii) Measurable indicators of performance where feasible; and
  - (iv) The budget allocated to the programme;

- (d) Payments to be made on behalf of the county government, including details of any grants, benefits and subsidies that are to be paid;
- (e) A description of significant capital developments;
- (f) a detailed description of proposals with respect to the development of physical, intellectual, human and other resources of the county, including measurable indicators where those are feasible;
- (g) A summary budget in the format required by regulations; and
- (h) Such other matters as may be required by the Constitution or this Act.
- (2) The County Executive Committee member responsible for planning shall prepare the development plan in accordance with the format prescribed by regulations.
- (3) The County Executive Committee member responsible for planning shall, not later than the 1st September in each year, submit the development plan to the county assembly for its approval, and send a copy to the Commission on Revenue Allocation and the National Treasury.
- (4) The County Executive Committee member responsible for planning shall publish and publicise the annual development plan within seven days after its submission to the county assembly'
- **Mr. Speaker sir,** the County Governments Act 2012 further provides that approval of county development plans is one of the mandates of the Members of County Assembly.
- **Mr. Speaker sir**, No public funds shall be appropriated outside a planning framework developed by the county executive committee and approved by the county assembly as stipulated in Section 104 of the County Government Act.
- **Mr. Speaker sir,** The Annual Development Plan of 2023/2024 was further discussed by all members of the County Assembly and the proposal submitted by sectoral committee chairpersons to the Budget and Appropriation Committee for deliberation and considerations.

#### 3.0 Kericho County Annual Development Plan for FY 2023/2024

**Mr. Speaker sir,** the annual development plan is prepared annually to guide departments, non-governmental organizations, civil society organizations, private sectors and development partners

on what the county government intends to do in each financial year. The plan forms the basis of preparing the budget for the same financial year. In addition, the plan is useful in tracking the achievements at the end of the financial year. It is in this light that the committee is mandated to scrutinize the annual development plan for all the departments and make recommendations for approval by this Honorable House.

## 3.1 Committee Observations on Kericho County Annual Development Plan for Financial Year 2023/2024

**Mr. Speaker sir,** the committee makes the following observations and recommendations on the Annual development Plan for Financial Year 2023/2024:-

- 1. The ADP 2023/2024 is a transition Development plan between the  $2^{nd}$  and  $3^{rd}$  Generation CIDP
- 2. That future public participation exercise be done at the Ward level.
- 3. That the projects proposed in the annual development plan for the financial year included new projects, on-going projects and multi –year funded projects;
- 4. That the activities in the annual development plan had not been prioritized per ward.
- 5. There were public interest lands that had not been captured in the county register.
- That additional projects in order of priority have been proposed for consideration in the annual development plan for FY 2023/2024 after Submission of the ADP to the County Assembly
- 7. That the current County Assembly offices space was too small, there was need for construction of a modern office block and chambers.

## 3.2 Committee Recommendations on Kericho County Annual Development Plan for Financial Year 2023/2024

1. That the department of Finance and Economic Planning should merge the proposals in the ADP with the 3<sup>rd</sup> Generation CIDP.

- 2. That Public participation be must be done at the ward level for it to be effective.
- 3. That the department of Finance and Economic Planning develop clear strategic planning for each financial year to avoid duplication.
- 4. That programmes in the annual development plan should be prioritized in a systematic manner for ease of implementation, monitoring and evaluation i.e. each ward's projects be captured independently.
- 5. The department of Lands, Housing and Physical Planning undertake land surveys and mapping including boundaries and fences, valuation and administration of state and trust land across the county;
- 6. That the annual development plan for FY 2023/2024 be approved with the amendments of programmes and projects herein annexed in order of priority per ward.
- 7. That the construction of County Assembly Offices be phased.

#### 4.0 Conclusion

Annual Development plan for FY 2023/2024 be approved with amendments.

Hon. Gilbert Ngetich (Member for Kisiara Ward): Thank you very much Mr. Speaker. I also want to appreciate and join hands with the Honorable Rogony I supporting the ADP which we ourselves made. Remember that you gave us a chance to go per Sub County we sat in Litein at the Social hall and we really interacted with the members of the public who gave us what is supposed to be put in the ADP. It was therefore produced after public participation as the public was included. This ADP will be a very good one because members will not do their own things but what the electorates demanded after talking and agreeing with them. The opportunity that you gave us to meet the electorates in our sub counties was a well thought of move which allowed us to ventilate on the projects that need priority. Though it was a sub county thing, we sat as members from the wards therein and agreed on the projects. This ADP 2023/2024 is electorate centered.

The Speaker (Hon. Dr. Patrick Mutai): Thank you very much. Hon. Moses!

**Hon. Moses Rotich (Member for Tendeno/Sorget):** Thank you very much for giving me this opportunity to comment on this ADP. We had an opportunity to assemble in Londiani Sub county headquarters of Kipkelion East with all the MCAs, leadership and the entire people from

our wards who contributed their agenda towards the development of this document. It will be an opportunity to have the development projects implemented. We urge the committee on implementation in future that as we progress we will have to measure the adoption of this project and the rate at which they are implemented. I support. Thank you.

**The Speaker (Hon. Dr. Patrick Mutai):** Thank you very much Hon. Moses. Hon. Fancy, Deputy Majority Leader!

Hon. Fancy Korir (Nominated Member representing Women): Thank you very much Mr. Speaker for this chance. I also rise to support this ADP which is going to put Kericho County in a very good place because when we went for the same, people were talking about reducing the rates on revenue collection and that is what we have done now. I really support because many people lost their businesses during the corona period. We are going to support them to get back to their knees in their businesses. Again as gender, representative of women, I ask that we be included in the budget because there are many things that we are supposed to be doing but we do not have a budget. One being Gender Based Violence (GBV) campaign that we did in the recent past. We did not have enough resources. I therefore request that we are included in gender mainstreaming so that we also have something to do for the people of Kericho County. Thank you.

**The Speaker (Hon. Dr. Patrick Mutai):** Thank you very much. The Majority Leader I saw your hand.

Hon. Paul Chirchir (Member for Kapsoit Ward): Thank you Mr. Speaker. I rise to support the motion on the report on ADP 2023/2024 and I want to laud the committee for coming up with programmes that will be running in the financial year 2023/2024 because the Public Finance Management Act is very clear on ADP, County Fiscal Strategy Paper (CFSP) and the other programmes. With the approval of these, the department of Finance will be able to do their procurement plan in conjunction with the ADP. So if ever they will do things outside what is in this ADP, they will be going against the law. If it was possible that all the 30 wards' programmes

are highlighted then it becomes long. We don't want a situation where new projects that are not in the ADP finds their way herein that will be against the law. I urge this House that once we approve the ADP for the FY 2023/2024 the department will not be able to bring anything new as is the practice. I support the approval of this ADP and with the approval of the new Chief Officers, projects, programmes and the procurement plans will be rolled out in good time. Thank you.

The Speaker (Hon. Dr. Patrick Mutai): Thank you so much. Honorable Ngetich!

Hon. Gilbert Ngetich (Member for Kisiara Ward): Thank you very much Mr. Speaker. I just want to inform the Honorable member from Kapsoit that we can pass the ADP with amendments and when we do that, it means we can go over sometime and check the CIDP. Whatever does not appear in the ADP we can slot in to salvage a situation. It however depends on how we pass the ADP. If with amendments, it will not close the inclusion of projects in the CIDP

The Speaker (Hon. Dr. Patrick Mutai): The Honorable Majority!

Hon. Paul Chirchir (Member for Kapsoit Ward): Mr. Speaker Sir that is why we have the Hansard Reports where resolutions once passed by this House are binding, we don't want even if this House approves Annual Development Plans with amendments, anything that has been amended is binding and forms part of Annual Development Plan. A situation where may be the Executive sits somewhere and introduces an item or something that is not in the ADP that is where I want to be very clear and go on record that anything that is not in the ADP should never see the light of the day. The wisdom of the framers of this constitution was very clear and that is why they said once the House approves County Integrated Development Plan that is a program which runs for five years, public participation is done members of public approves it gets to the house then it is approved and becomes binding. Once approved there is County Fiscal Strategy Paper (CFSP) which sets the sealing for each department then now the ADP which picks programs from the CIDP that is why I was explaining such that when amendment is made it gets in to the annual development plan, but where the executives introduces things that are not in the

ADP that is illegal that is why I was saying this thing once is approved, it is public document it goes to the public so that nothing new is introduced. If there will be amendments which the House approves them it forms part of ADP.

The Speaker (Hon. Dr. Patrick Mutai): Alright thank you very much, The Hon. Martin!

Martin Cheruiyot (Member for Kapkugerwet Ward): Thank you Mr. Speaker while I applaud this ADP, I want to raise a concern and maybe I need also to be informed, because as Hon Paul Chirchir has said once it is approved we may not have any other projects coming in .I have a concern for my ward, the list of some of the projects that I am seeing here are not the projects that were forwarded. Most of them actually are the projects that were not forwarded when we did our sub county public participation .So maybe I will need also to be informed by honorable Speaker on these projects because some of the projects here that I have seen are already done, so if possible give some room of slotting in some new projects that will be incorporated in the ADP.

The Speaker (Hon. Dr. Patrick Mutai): Yes Honorable Majority!

Hon. Paul Chirchir (Member for Kapsoit Ward): Thank you Mr. Speaker Sir, for the Hon. Martin Cheruiyot we will give him that benefit of doubt because he is a new member, his primary role is representation he sits here on behalf of the thousands of Kapkugerwet ward members who went and participated in a public participation. What his members proposed, he is at liberty to make amendments to move an amendment and request a member to second his amendments and list what he thinks should be in 2023/2024 financial year.

The Speaker (Hon. Dr. Patrick Mutai): Thank you very much Honorable Majority. First Hon. Martin even before we proceed I want to take you back to the report on page No.8. This report by Hon. Kiprotich Rogony who is the Chairman County Budget and Appropriation Committee and may be just to quote, I wish to confirm that the recommendations in this report were unanimous. If you go the composition of this committee, Hon. Martin you are part of this committee, so the question is because when you say the things that are here are not the right

things or the right projects or programs in your ward. So perhaps even before I give to the Hon. Rogony to make comments on the same, I want to first of all talk about this Annual Development Plan. Hon. Kiprotich Rogony (Chairman Budget and Appropriation Committee, Member for Sigowet Ward): Thank you Mr. Speaker, first of all let me inform the member, one in our engagement first there was a template that we gave to each and every member. We gave them an opportunity to submit the list of their projects to be included in this ADP in order of their priority, I wish to maybe the member should come and probably inform the House on what might have happened because one the projects captured was part of what was given out during the public participation. So this report and I have read page 8 in conclusion and I requested the House to pass this report with amendments that means should there be anything new it can still be incorporated as long as it is derived from CIDP there. In the observation we made a raft of changes one we intend to merge this ADP with the CIDP that is generation three, so maybe the member had a different view but I think most of the things that we have here pertaining to Kapkugerwet ward is what was submitted to the staff who participated in the public participation

and even the member himself. We gave him the template to submit the projects that he wanted done in in this financial year in order of priority. Thank you Mr. Speaker.

**Hon. Martin Cheruiyot** (**Member for Kapkugerwet Ward**): Thank you Mr. Speaker, now I'm reliably informed on this document that we can pass it with amendment and as Hon. Albert has said, I think I have been informed that for purposes of procurement, maybe we can pass and then we can slot it in if there is that room for the projects that are of priority especially in my ward. Otherwise what I was saying is that the projects that are listed some of two or three projects are already done with amendments. I am informed and I support the motion. Thank you.

The Speaker (Hon. Dr. Patrick Mutai): Thank you very much, Hon Anita Mibei!

**Hon. Anita Mibey** (**Member for Chemosot Ward**): Thank you Mr. Speaker, I would like to support the approval of the Annual development Plan especially with amendment. I was worried a little bit when Hon. Paul Chirchir *Fuata Sheria* was saying that anything else that comes after will not be approved in this House. My worry goes to my neighbor Hon. Birir from Kapkatet

Ward.   - 1) Reuben Yegon, (Chairperson-not a public officer);
  - 2) Doris Ngeno (Advocate and Member of LSK)
  - 3) CPA Kipkemoi Cheruiyot (Accountant/Member of ICPAK)
  - 4) Eunice Kirui (Private Sector)
  - 5) Wesley Siele (representative from an Association representing Workers)

5. The notification contained the nominee's curriculum vitae.

#### 2.2 Notification to the Assembly and Referral to the Committee on Appointments.

- 6. Pursuant to the provisions of Standing Order 45(1) the Speaker, vide a communication dated 15<sup>th</sup> November 2022 informed the House of the Governor's message to the House on submission of the panel for selection of the County Secretary /Head of County Public Service.
- 7. Pursuant to Section 7 (1) of the Public Appointments (County Assemblies Approval) Act No.5 of 2017 and Standing Order 199 the names and curriculum Vitae were referred to the Committee on Appointments.

#### 2.3 Notification to the Public and Nominees

- 8. Section 7 (4) of the Public Appointments (County Assemblies Approval) Act provides that the Clerk shall notify a candidate of the time and place for the holding of an approval hearing by notice in at least two newspapers of national circulation and by writing and by such other form of communication as the Clerk may consider appropriate.
- 9. Section 7 (5) of the Public Appointments (County Assemblies Approval) Act the committee shall by notice in at least one newspaper of national circulation notify the public of the time and place for holding an approval hearing at least 7 days prior to the hearing.
- 10.Pursuant to Section 7 (4) & (5) of the Public Appointments (County Assemblies Approval) Act, the Clerk of the County Assembly placed an advertisement in the print media on 16<sup>th</sup> November 2022 (*Annexure 2*) inviting the members of the public to submit memoranda by way of written statement on oath (affidavit on the suitability or otherwise of the nominees). The advertisement indicated that the submissions were to be received by 21<sup>st</sup> November 2022 at 4.00pm.
- 11. The same advertisement invited the nominees to appear before the Committee on Appointments at the Assembly Chambers. The Nominees were required to bring their original copies of their national identity cards, academic and professional certificates and other relevant testimonials and clearance certificates from the following institutions:

# 2.5 Issues for consideration during the Approval Hearings/Constitutional and Statutory Requirements

- 13. Section 8 of the Public Appointments (County Assemblies Approval) Act outlines issues that need to be considered by the committee in relations to nominations. They are as follows:
  - a) The procedure used to arrive at the nominee including the criteria for the short listing of the nominees;
  - b) Any constitutional or statutory requirements relating to the office in question; and
  - c) The suitability of the nominee for the appointment proposed having regard to whether the nominee's credentials, abilities, experience and qualities meet the needs of the body to which the nomination is being made.

#### (a) Procedure for nomination

Section 44 (2 A) of the County Government Act requires the Governor to constitute a selection panel that will competitively recruit the County Secretary and the Public Appointments

#### (b) Constitutional and Statutory Requirements

- i. The Constitution of Kenya 2010 read together with the County Government Act in addition gives guidelines on how to appoint persons who will be appointed to serve in the selection panel that would appoint the County Secretary/Head of County Public Service.
- ii. Composition of the Selection Panel
  Section 44 (2B) provides for composition of the Selection panel which is as follows:
  - a) A chairperson ,not being a public officer

- b) One person from the private sector
- c) An Advocate of the High Court of Kenya ,who is a member of the Law Society of Kenya
- d) An accountant who is a member of the Institute of Certified Public Accountants of Kenya; and
- e) One person from an association representing workers.
- iii. Leadership and Integrity
- 14. The committee, in determining the suitability of the nominees was also guided by the provisions on Leadership and Integrity as outlined under Chapter 6 of the Constitution. In Particular, Article 73 (2) of the Constitution provides that the guiding principle of Leadership and Integrity include:
- a) Selection on the basis of personal integrity, competence and suitability, or election in a free and fair election;
- b) Objectivity and impartiality in decision making, and in ensuring that decisions are not influenced by nepotism, favoritism, other improper motives or corrupt practices;
- c) Selfless service based solely on the public interest, demonstrated by
  - i. Honesty in the execution of public duties; and
  - ii. The declaration of any personal interest that may conflict with public duties;
- d) Accountability to the public for decisions and action; and
- e) Discipline and commitment in service to the people.
  - 15. In addition, the committee considered section 10 of the Leadership and Integrity Act 2012 in particular which provides that –

A state officer shall to the best of their ability-

- a) Carry out the duties of the office efficiently and honestly;
- b) Carry out the duties in a transparent and accountable manner;
- c) Keep accurate records and documents relating to the functions of the office; and
- d) Report truthfully on all matters of the organization which they represent.

The committee noted that all the nominees complied with the provision of chapter 6 of the constitution of Kenya 2010 on leadership and integrity and that the nominees submitted clearances from EACC, CRB, HELB and DCI.

- d) That the nominee demonstrated the capability of serving as a member of the Selection Panel.
