# MOTION BY MAJORITY LEADER (HON. PHILIP RONO, MEMBER FOR KAMASIAN WARD)

**The Speaker (Hon. Dr. Patrick Mutai):** The honorable Majority Leader please proceed with your motion!

**Hon. Philip Rono (Majority Leader, Member for Kamasian Ward):** Thank you Mr. Speaker for giving me the opportunity once again. I wish to start from page 1 of the report.

### **1.1 Mandate of the Committee**

Standing Order 167 of the Kericho County Assembly Standing Orders mandate the Committee on Selection to nominate members to serve in committees save for the membership of the County Assembly Business Committee and the Committee on Appointments.

The Committee placed members to various committees in October 2022 and tabled a Report that was adopted by the House on 25th October 2022.

3 However, there was a general feeling of dissatisfaction with the committees that members had been placed. Further, there were changes in House leadership on two occasions that led to changes in the composition of some of the committees.

4. Additionally, there emerged divisions in the House which was blamed on the composition and leadership in the committees as had been constituted.

5. Consequently, a meeting was organized by the Deputy President H.E. Rigathi Gachagua on Thursday 19th January 2023 to address the divisions in the House where new House leadership was agreed upon as Hon. Philip Rono, Hon. Haron Rotich, Hon. Fancy Korir and Hon. Bavina Serem as Majority Leader, Majority Whip, Deputy Majority Leader and Deputy Majority Whip respectively. Further, a call was made to the County Assembly to address any other concern that was deemed to have contributed to divisions among them composition and leadership of County Assembly committees (Chairpersons and Vice Chairpersons).

6. To address the concerns in membership and leadership of committees, the committee on Selection was mandated to reconstitute the membership of all the committees in a

communication by the Honorable Speaker delivered on Friday 20th January 2023 during a Special Sitting.

7. The Committee on Selection that was constituted on 5th October 2022 was maintained and its composition is as follows:-

- 2.0 The Nomination Process

In the reconstitution of the Assembly Committees, the committee on Selection adopted the following criteria:

- Members' wishes a)
- Need to ensure regional balance b)
- Gender balance c)
- Perceived strength of committees d)

- e) Sectoral vs House Committees
- f) Leadership positions in the House and the County Assembly Service Board
- g) The last two adopted committee lists
- h) Members' profession

The Committee was also guided by the Constitution, Standing Orders and the County Government Act, 2012.

The Committee on Selection further noted that the current placement of members in committees was an extra-ordinary duty that called for extra ordinary measures since it was the third in a period of four months. The committee invoked the provisions of the Kericho County Assembly Standing Order 169 (1) and (2) which states as follows;

"(1) In nominating Members to serve in a select committee, the Selection Committee shall ensure that the membership of each committee reflects the relative majorities of the seats held by each of the Assembly parties in the Assembly.

(2) Despite paragraph (1), a member belonging to a party other than an Assembly party or independent member may be nominated to serve in select committee and the allocation of membership of select committees shall be as nearly as practicable proportional to the number of members belonging to such parties and independent members."

Despite the above provisions, the Committee on Selection, in the spirit of togetherness and the need to bring lasting unity in the Assembly ensured that all the Hon. Members were placed to serve in the committees. The committee however, resolved to have the Majority Party members take the leadership of committees while considering regional balance and proportionate representation in the six sub counties.

The committee, in consultation with the Majority Party further considered the need to have every member actively participating in committees by allocating them responsibilities as Chairpersons, Vice chairpersons and members of the Speaker's Panel.

12. Considering the fallout that characterizes any competitive election and the need to seal out the perceived differences, the committee in consultation with the house leadership and the Majority Party resolved not to subject the Honorable members to a further election save for Committee on Budget and Appropriations that is composed of all elected members, as this could bring further divisions in case of a loss in committee elections.

### 3.0 Committee Observations

The Committee observed the following:

1. That all Honorable Members have been placed to have responsibilities in committees as Chairpersons, Vice Chairpersons or members of the Speaker's Panel.

2. That as much as was practicable, the committee on Selection ensured regional and gender balance in the placement of members to committees.

3. That change in House Leadership led to changes in membership of certain committees whose membership is determined by the House Leadership such as Committee on Selection and Appointments.

4. That the Standing Orders peg the number of sectoral committees assigned to a member to a maximum of three.

**The Speaker (Hon. Dr. Patrick Mutai):** Honorable members, before I open the floor, let me refer you to Standing Order number 170(2) which reads; whenever a motion for approval of a list under paragraph (1) is moved in the Assembly, no objection against the proposed membership of a member in a select committee shall be permitted and objections, if any, shall be formulated against the proposed membership as a whole. Please be guided accordingly. I now open the floor for members to make their contribution. The Hon. Paul Chirchir!

**Hon. Paul Chirchir (Member for Kapsoit Ward):** Thank you very much Mr. Speaker for giving me an opportunity to make my contribution on the report nominating members to different committees. I rise to support the motion by the honorable Majority Leader. Looking at the composition of each committee, the gender rule is very clear and the Standing Order number 170 is also very clear. Now we have to start working because the strength of the Assembly is in the committees, this Assembly will be as strong as the committees. Our roles as the Members of County Assembly are very clear, oversight, representation and legislation and we can only do oversight through the committees.

The committee on Finance and Economic Planning should seriously take up their responsibility because the revenue targets have not been met for the last five years. I wish to congratulate our chairperson the Hon. Hillary Bosuben and tell him that the task before him is enormous and he has our support as the committee members. This is February and we have two more months to the close of the financial year, we have this year's budget to implement between now and June. We have not been able to see any development being rolled out because of the issues of Chief Officers and now that the Chief Officers have been given rights they do not have the luxury of time and as committees it's high time that we move with speed. Roads, water projects and ECDE (Early Childhood Development Education) have not been rolled out because of the issues that

have been addressed. Now we will be able to raise statements through the committees. We hope to see members raising statements from next week in terms of work in various wards. Lastly I wish to congratulate the Committee on Selection led by our able Majority Leader and say thank you to them for doing a very good job and now to the 47 Members of this County Assembly. Let us put our differences behind us and work as a team. When we succeed we succeed as an Assembly. Let us move with speed and make sure that things are rolled out. Thank you very much.

**The Speaker (Hon. Dr. Patrick Mutai):** Thank you very much the honorable Paul Chirchir, the floor is still open for members to contribute. I hope silence means concurrence and I can see that everyone is smiling. I must congratulate the Majority Leader; I think you did a very good work because I have not heard anyone complain. I want to commend you on what you did especially considering gender balance, regional balance, I think that is the way to go. Having no more contributions I want to request the Majority Leader to reply.

Hon. Philip Rono (Majority Leader, Member for Kamasian Ward): Thank you very much Mr. Speaker, mine is just to thank the House for having trust in what we did. My only request to your office is that you arrange an induction for these members on various committees for the members to get some experience on their respective committees. The only challenge that I had is that people were thinking that some committees like the Delegated County Legislation is a dormant committee but I want to assure them that we have several legislations that have been passed in the County Executive and the County Assembly that have not been implemented because of previous dormant chairpersons of that committee. I therefore request that the Hon. David Maritim reintroduces the same bills and policies for consideration by the House that were just drafted by the County Executive but were not passed. I also want to warn the chairpersons who will not take their work seriously that our office will take serious actions on them; you will be whipped if the committee members raise concerns over your performance.

Finally I want to once again thank the honorable members for having confidence in this report. Thank you and God bless you all.

**The Speaker (Hon. Dr. Patrick Mutai):** Thank you very much Majority Leader Hon. Philip Rono. I hope you will not whip The Speaker because he is also a chairperson of a number of committees but I can assure you that I will work hard to ensure that the committees that I chair work effectively and efficiently.

**The Speaker (Hon. Dr. Patrick Mutai):** Honorable members now that the report has been approved by the House, I got three communications to make.

Thirdly, the report that has been adopted has a proposal that the election of the chairperson Budget and Appropriation Committee be done immediately after this. I direct the Office of the Clerk that the election be done on Tuesday the 14th February 2023 at 10a.m and that whoever will be the runners up will be the vice chairperson. I hope the Majority Leader has noted that so that you communicate to the other members.
