THE KERICHO COUNTY APPROPRIATION BILL, 2023

The Temporary Chairperson (Hon. Cheruiyot Bett): Thank you Honourable Members. I want to take this opportunity to welcome you to the Committee of the Whole House. Clerk, please call out the clauses.

Clause 2 Chairman, talks about the County Treasury may issue out of the County Revenue Fund and apply towards the supply for the services of the year ending 30th June, 2024. The reason why there are changes is because by the time we requested for the publication of this document, we had not finalised with it but after finalising it today, those figures changed from Five to Nine because of the unspent funds.
