# MOTION BY THE VICE CHAIRMAN APPOINTMENT COMMITTEE HON. HEZRON NGETICH

The Speaker (Hon. Dominic Rono): Thank you Leader of Majority!

**Hon. Hezron Ngetich:** (Vice Chairman Appointment Committee): Thank you Honorable Speaker for giving me this opportunity so that I can move a motion of the approval report on vetting of nominee for the post of Deputy Governor, Mrs. Lily Chepngetich Ngok.

#### VETTING OF MS. LILY CHEPNGETICH NGOK

Ms. Lilly Chepngetich Ngok of national Identification Number 11635711, nominee for the position of Deputy Governor, Kericho County Government appeared before the Committee on Appointments on Tuesday 13<sup>th</sup> April 2021 and was examined under oath and the approval hearing commenced as per the Public Appointments (County Assemblies Approval) Act, 2017 and the County Assembly Standing Orders.

#### Date and place of birth

She is a Kenyan citizen born in 1973. She hails from Kipkelion East Sub-County, Kericho County.

# Academic Qualifications

She attended Kipsigis Girls' High School and completed in the year 1993 with a Kenya Certificate of Secondary Education.

She is a graduate of Egerton University having graduated with Bachelor of Education (Arts). She also holds a Diploma in Human Resource Management from Kenya Institute of Management.

She holds a Masters Degree in Religion (Church Based) from North West University.

# Employment record

The nominee previously worked as a secondary school teacher at Kabokyek and Kaminjeiwet Secondary Schools. She also worked at Kisii University as Senior Administrative Assistant. She is currently the County Executive Committee Member in charge of Education, Youth Affairs, Sports, Culture and Social Services and while in that capacity she has served as Acting Deputy Governor for a period of one month in January 2021. Cumulatively, the nominee has over 16 years of work experience.

### Integrity

The nominee submitted a Tax Compliance Certificate from the Kenya Revenue Authority valid up to 22<sup>nd</sup> April 2021.

The nominee provided the committee with a Certificate of Clearance No.225369 from the Higher Education Loans Board valid until 12<sup>th</sup>April 2021.

The Director of Criminal Investigations issued the nominee with a Police Clearance Certificate PCC-AAALOWX5 dated 8<sup>th</sup> April 2021.

The Nominee attached an Application for clearance from the Ethics and Anti-corruption Commission dated 1<sup>st</sup> April 2021. The nominee also provided clearance certificate from *MetroPol* Credit Reference Bureau dated 28<sup>th</sup> February, 2021.

#### Vision and leadership

The Deputy Governor is the principal assistant to the Governor. The nominee told the committee that her vision is to assist the Governor complete the projects and programs that he has initiated and provide leadership to various sub-committees of the County Executive Committee.

The nominee also stated that her strategic objectives include ensuring that all accounting officers deliver in their respective departments to achieve the overall objective of improving the livelihoods of the county residents.

#### General questions to the nominee

The committee asked the nominee very critical questions regarding her work experience and specifically the 11 months that the nominee has served as the County Executive Committee Member in charge of Education, Youth Affairs, Sports, Culture and Social Services. She defended her track record in the department explaining that her docket not only covers ECDE but also youth affairs and gender. She told the committee that she has held meetings with the youth and has taken 10 youths for an empowerment course at the Kenya School of Government. She further told the committee that she has taken 50 women for a conflict resolution conference in Nyamira. The nominee further said that there were many other ongoing projects in the department including equipping of ECDE Centers and youth polytechnics.

The nominee further defended herself regarding the low absorption of development funds in the Department of Education noting that development funds had already been committed and contracts completed but the contractors had not handed in their documentation for the processing of their payments.

Regarding the low remuneration of ECDE teachers, the nominee told the committee that most teachers had not registered with the Teachers Service Commission (TSC) and hence they lacked bargaining power for better pay. She said that she had addressed the matter by ensuring that all the teachers with the required qualifications were registered with TSC so that they can gain recognition and hence better remuneration.

On revenue collection in the County, the nominee told the committee that if approved, she will ensure that all Chief Officers map all revenue streams and automate them, and also do away with receipt system to seal loop holes of revenue pilferage and come up with cash less system by ensuring parking is systematized.

The nominee was also asked on how she intends to help the Governor complete the stalled projects in the County. The nominee told the committee that she will work closely with the CECs and COs to ensure that all stalled projects are completed before new ones are started. She further said that she will be keen to ensure that all accounting officers become accountable in their dockets so as to spur development.

#### Committee observations

The Committee having considered the criteria as provided by vetting tool, her Curriculum Vitae and having heard her oral submission during the vetting interview, made the following observations on her suitability for appointment as Deputy Governor, County Government of Kericho:

- 1. That she possesses academic qualifications, knowledge and vast experience in leadership and governance.
- 2. That she provided all documents as required in chapter six of the Constitution of Kenya 2010, about leadership and integrity.
- 3. That she exhibited knowledge touching on her docket and has requisite abilities and experience.

Therefore the committee found the nominee suitable for appointment as Deputy Governor, County Government of Kericho.

Mr. Speaker on subsequent pages there are annexure of nomination gazette notice provided as evidence that due process was followed. Before I welcome somebody to second the motion we did good work by following the due process which is laid down by the Constitution and County Government Act in ensuring that Mrs. Lily Ngok goes through the right process during her vetting. We found that her academic qualifications fit to be nominated or to be approved. On

top of her qualification, she has a Diploma in Human Resource and you know as Deputy Governor she will be in charge of administration and all other employees in the County so the experience she has on that will aid her in running and overseeing all the workers and County Government employees.

Before she was appointed as the CEC in charge of Education, she served as Dean of Student Kisii University and you know that Kisii University is a big institution that is chartered and we have never heard any rampage. That means that she has all the qualities of leadership and she handled the students in the university in an organized manner. It is therefore not going to be a big deal for the County Government because she has demonstrated that she works smart. If you compare her with other CECs that were appointed before her, I think she might be the only CEC or among the few CECs who has criss crossed the wards in the entire County. She has participated in the Community Social Responsibility social function to mean this lady loves her work and now given another opportunity because she is equipped I know she will deliver and assist the Governor be spear head the agenda and his manifesto. So without elaborating more you will allow me to welcome Honorable Philip Rono to second this motion.

The Speaker (Hon. Dominic Rono): Hon. Philip Rono!

**Hon. Philip Rono:** Thank you very much Mr. Speaker, I just rose to second the report on the approval of Ms. Lily Chepngetich Ngok to be the Deputy Governor of Kericho County. Am among the Committee members of the Appointment and from the observation Mrs. Lily Chepngetich Ngok was so composed and from the report we have here by all means she fits to be the Deputy Governor Kericho County Thank you very much and I urge the House to continue supporting her for the services to the people of Kericho County. Thank you very much.

The Speaker (Hon. Dominic Rono): Hon. Hezborn Tonui!

**Hon. Hezborn Tonui**: Thank you Mr. Speaker for allowing me this chance to support the motion of appointment of Ms. Lily Ngok to be the Deputy Governor of Kericho County. I want

to say that we lost our beloved Deputy Governor Susan Kikwai and at this juncture we are privileged to have Mrs. Lily Ngok who will take her position to be the Deputy Governor and we want to say thanks to H.E the Governor Kericho County Prof. Paul Kiprono Chepkwony for appointing this lady who was the CEC in charge of Education and I arise to support on behalf of the people of Cheplanget. **Hon. Haron Rotich:** Thank you Honorable Speaker I want to join my colleagues from the Appointment Committee for the approval of Madam Lily Ngok. However it happened that I was

**Hon. Beatrice Tonui:** Thank you Mr. Speaker for giving me this opportunity so that I may contribute towards the approval of Lily Ngok. First of all let me take this opportunity to say Rest In peace Madam Susan Kikwai I want to say thank you to our Excellency Governor for giving us another chance as women. I stand to support her. Thank you.

The Speaker (Hon. Dominic Rono): The Honorable William Soi!

**Hon. William Soi:** Thank you Honorable Speaker for giving chance to the people of Chemosot. I stand to support the nominee Lily Ngok to be the Deputy Governor of Kericho because on the

Hon. Eric Bett: Thank you Mr. Speaker for giving me this chance to support the motion for the Committee on Appointment. I want to join my colleagues to also pay tribute to our late Deputy Governor Madam Susan Kikwai and I wish to also congratulate the committee on appointments for the well written report that is self-explanatory. I want to give my two reasons why I support this report; first and foremost is that if you look at the employment record of Madam Lily Ngok, she has over sixteen years of experience of which she has worked some in the public sector that is in the County Government as the CEC and I noted in the report that in the month of January, she acted as the Deputy Governor for one year and that is a big plus because once we approved

Paul Chirchir:** Mr. Speaker Sir, I rise on a point of order where County Government Act 2020 that the office of the Deputy Governor shall become vacant if the holder of the office (a) were if dies, so there is a vacancy in the Deputy Governor's office because of (a) Mr. Speaker Sir, 32(d) where vacancy arises in the office of the Deputy Governor as provided for under section 32(c) above the Governor shall within 14 days nominate the Deputy Governor (b) with the approval of the County Assembly appoints a Deputy Governor. Shall be a person eligibly 32(b) (d) ...

**The Speaker (Hon. Dominic Rono):** Order Honorable Paul Chirchir! Honorable Anthony Rutto was on his feet to support the report unless what he was saying was not right then you can proceed. What was he saying that wasn't right?

**Hon. Paul Chirchir:** I was saying that as we stand today the County Government Act is very clear; the Deputy Governor Madam Lily Ngok is already the Deputy Governor. Thank you.

The Speaker (Hon. Dominic Rono): Please proceed Honorable Anthony Rutto!

Hon. Anthony Rutto: Thank you Mr. Speaker, finally I want to agree with our able Majority Leader for saying that Lily Ngok is a committed and a focused person as witnessed in the eleven months that she has been in the office. Hon. Paul Chirchir: I am building my case.

The Speaker (Hon. Dominic Rono): We are aware of the law so please proceed.

**Hon. Paul Chirchir:** I am building my case by saying this is the reason why I support. The law which I know you are aware of says that the County Assembly shall consider a motion for approval for the appointment of the Deputy Governor within 14 days and resolve whether to approve the motion and be deemed to have approved the motion for the appointment of the Deputy Governor upon the lapse of the 14 days and having failed to make a resolution, I said I support this report. This is a formality because the 14 days which the law says have already lapsed. So in short Her Excellency Lily Ngok is the Deputy Governor but none the less I fully support this report.

The Speaker (Hon. Dominic Rono): The Honorable Sammy Rono!

**Hon. Sammy Rono:** Mr. Speaker I rise on a point of order! Mr. Paul Chirchir wants to tell us that whatever we are discussing now ...

**Hon. Sammy Rono:** Hon Paul Chirchir, so I rise on point of order that if Hon. Paul Chirchir is confirming to us that already Lily Ngok is the Deputy Governor, then what we are discussing is to the contrary? Can you clarify that?

**Hon. Philip Rono:** I think Mr. Speaker Hon. Paul Chirchir is not in order for taking us rounds. From the look of things even from our own observations Honorable Paul Chirchir has worn two masks to mean that we have a very serious pandemic in this area and that affects a lot of work that we are undertaking as a County Government. I don't think Hon. Paul Chirchir is in order to allege that the report we are discussing is past the timelines. Thank you.

**The Speaker (Hon. Dominic Rono):** Hon. Paul Chirchir please restrain yourself from those issues because we have given you directions, just conclude.

**Hon. Paul Chirchir:** Thank you Mr. Speaker I said I stand guided by you and the reason why I said I support this report is because I made few observations; number one, a third gender rule is very clear we appreciate the governor, he supports women and he is very firm. He said during the send off that he was going to fill the vacant position by giving it to a lady, this has happened.

Secondly, in the few months she has been in office there are few challenges here and there, few misgivings but she has been able to try, she has been able to do one or two things here and there
