The contents of this letter is, the Public Finance Management (PFM) Section 123 states that on or before 28<sup>th</sup> February in each year, the County Treasury shall submit to the County Assembly a statement setting out the Debt Management Strategy of the County Government over the Medium Term with regards to its actual liability in respect to loans and its plan for dealing with those liabilities.

So I will commit the County Debt Strategy Paper 2021 to the committee on Budget.

The public finance Management Act, 2012 section 117, states that the County Treasury shall prepare and submit to County Executive Committee the County Fiscal Strategy Paper for approval and the County Treasury shall submit the same to the County Assembly by 28<sup>th</sup> February of each year.

Hon. Grace Koech: Committee observations

The committee on Governance Labour and Social Welfare observed as follows:-

- i. That the County Government of Kericho needs the office of the County Attorney to guide the county government on all legal issues.
- ii. That the Office of the County Attorney is already anchored in law and hence it is the obligation of the County to establish the office.
- iii. That the procedure for the establishment of the offices in the County Public Service was followed.

Committee recommendations

The committee on Governance, Labour and Social Welfare recommends as follows: -

- i. That the establishment of the Office of the County Attorney is approved.
- ii. That the various departments of the County Government ensure that provisions of Section 62(4) of the County Government Act 2012 is not violated which states that: -*"If the County Public Service Board establishes an office and the concerned department fails to fill the vacancy for a period of twelve months after its establishment, the office shall stand abolished and the County Public Service Board shall not be required to make a decision to abolish that office"*

iii. That when the office of the County Attorney is established, it should be captured in the approved county organizational Structure.
