THE KERICHO COUNTY APPROPRIATION ACT

No. 3 of 2014

Date of Assent: 30th June, 2014

Date of Commencement: 1st July, 2014

AN ACT of County Assembly of Kericho to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on the 30th June, 2015 and to appropriate those sums for certain public services and purposes

ENACTED by the County Assembly of Kericho as follows—

1. This Act may be cited as the Kericho County Appropriation Act, 2014.

Short title.

2. The treasury may issue out of the consolidated fund and apply towards the supply granted for the service of the year on the 30th June, 2015, the sum of Kenya shillings four billion, five hundred and fifty-three million, one hundred thirty-one thousand, five hundred and nineteen that sum shall be deemed to have been appropriated as from 1st July, 2014 for the services and purposes specified in the schedule.

Issue of a sum of KSh. 4,553,131,519 required meeting public expenditure during the financial year ending on the 30th June, 2015.
