## THE KERICHO COUNTY APPROPRIATION ACT, 2015

Date of Assent: 28th May, 2015

Date of Commencement: 29th May, 2015

AN ACT of County Assembly of Kericho to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on the 30th June, 2014 and to appropriate those sums for certain public services and purposes

**ENACTED** by the County Assembly of Kericho as follows—

#### **Short title**

- **1.** This Act may be cited as the Kericho County Appropriation Act, 2015.
- 2. The treasury may issue out of the consolidated fund and apply towards the supply granted for the service of the year on the 30th June 2016 the sum of Kenya shillings Five billion, Eighty One million, Sixty Four thousand and thirty eight that sum shall be deemed to have been appropriated as from 1st July 2015 for the services and purposes specified in the schedule.
