AN ACT of County Assembly to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on the 30th June, 2014 and to appropriate those sums for certain public services and purposes

ENACTED by the Kericho County Assembly as follows:—

1. This Act may be cited as the Supplementary Appropriation Act, 2014.

2. The treasury may issue out of the consolidated fund and apply towards the supply granted for the service of the year on the 30th June 2014, the sum of Kenya shillings three billion, six hundred and thirty two million, sixty three thousand, seven hundred and fifty four and that sum shall be deemed to have been appropriated as from 1st July 2013 for the services and purposes specified in the schedule.
