APPROPRIATION (No. 2) ACT, 2016
No. 2 of 2016**

Date of Assent: 16th May, 2016

Date of Commencement: 18th May, 2016

AN ACT of the County Assembly to authorize the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on the 30th June, 2016 and to appropriate those sums for certain public services and purposes

ENACTED by the County Assembly of Kericho as follows—

1. This Act may be cited as the Kericho County Supplementary Appropriation (No. 2) Act of 2016. Citation.

2. The treasury may issue out of the consolidated fund and apply towards the supply granted for the service of the year on the 30th June, 2016 the sum of Kenya shillings Five billion, Five seventy million, One hundred and Fifty Six thousand Two Thirty Four, that sum shall be deemed to have been appropriated as from 1st July, 2015 for the services and purposes specified in the schedule.
