2.0 VETTING PROCESS

The vetting process is guided by the following laws;

- 1. The Constitution of Kenya, 2010;
- 2. The County Government Act, No.17 of 2012;
- 3. The Public Appointments (County Assemblies Approval) Act, No. 5 of 2017;
- 4. The Kericho County Enterprise Fund Act, 2014; and

3.0 NOTIFICATION OF THE VETTING EXERCISE

The nominees were notified through formal invitation by the County Assembly Clerk. The approval hearing was held at the County Assembly Chambers on 10th December, 2019.

4.0 CLEARANCE REQUIREMENTS

The nominees were required to submit clearance certificates from the following institutions;

- 1. The Ethics and Anti corruption commission;
- 2. The Kenya Revenue Authority;
- 3. The Higher Education Loans Board;
- 4. The Criminal Investigation Department; and
- 5. The Credit reference Bureau.

5.0 CRETERIA FOR VETTING

The criteria of vetting shall be guided by Section 7 (9) of the Public Appointments (County Assemblies Approval) Act, 2017 which provides that the criteria specified in the first and second schedule of that Act shall be used by the Committee during an approval hearing.

6.0 SUBMISSION OF PETITION

Section 7 (10) of the Public Trade and Industrialization (County Assemblies Approval) Act, 2017 provides that any person may prior to the approval hearing and by a written statement on Oath, provide the Clerk with evidence contesting the suitability of a candidate to hold office to which the candidate has been nominated.

7.0 VETTING OF NOMINEES

- a) Ensure all loan management systems are computerized and that due diligence is done before disbursement to the beneficiaries.
- b) Look into integrity of the personnel managing the fund.
- c) As a policy maker, ensure that the fund is revolving.

- d) Facilitate training of beneficiaries on the development of business proposal and management of business.
- e) Closely monitor the beneficiaries including establishing co guarantee mechanism.

The Committee observed that the nominee represents women and that she performed well during the vetting process. The committee therefore recommended her for approval.

The nominee when asked about the Challenges he encountered managing loan in a SACCO, He responded that the greatest challenge was a high rate of loan default. He further suggested that through training of clientele, offering advice to borrowers on the prudent use of loans comprises solutions to loan in default.

He further reiterated that there was need to prudently manage the enterprise fund so as to generate revenue to the county and foster economic growth.

Conducting proper appraisals before disbursing and constituting a sub - committee within the board to monitor the loans, as well considering disbursement to already existing businesses with aim of employing youth and generating income were some of his plans on the enterprise fund.

Members are still young, they can go on recovery well for the previous allocations or money which were given to members who never return back and again I think they will give out the money and they will

I would like to encourage the Honorable member to appreciate nature. My issue was that my wish was to have six board members representing our constituencies. I would like to get some clarification from the member because now that we don't know which constituencies these people come from, am wondering how the representation will be done in different constituencies. Otherwise as the committee has gone ahead and did the good work, I want to say that they have tried their best and we want this board in place because we want to make sure that our young business women, men and youths from different constituencies and wards are empowered. Mr. Speaker sir, I want to support the nominees of the four members to the board. My happiness is that each of the four members has the experience and the experience that they are bringing in Mr. Speaker will assist in the disbursement or the distribution of the enterprise fund and the training. I have looked at it and I have seen that each one of them is talking of the empowering the beneficiaries before the disbursement of the fund. And also when they are coming in, they will put in place the monitoring mechanisms to monitor how the beneficiaries will be using the funds. So Mr. Speaker sir, I know if they will be given maximum support and free hand to work, they will be of much benefit to our county, so I support this motion. I want to thank the team that was doing the vetting. Finally as I conclude, I hope those members who did not submit the tax compliance and the clearance from the Ethics and Anti-Corruption Commission should not be followed to do the same. It is only that I had one concern when it comes to the nomination of one Mr. Kipngeno Mutai, though I support. When it comes to employment record, just allow me read so that I can say what the concern is. It is in page 15, Mr. Kipngeno Mutai when it comes to employment record, it says he is currently working at Street Kenya Limited at Makueni, Kajiado and Uasin Gishu County since 2018 Mr. Speaker as a project supervisor, micro finance iMlango project. Number 2, he previously worked at Juhudi Kilimo Company since 2014 to 2017 at Kapsowar, Kitale as a branch manager. Mind the title, as a branch manager. The letter here is a project supervisor yet he walked at Juhudi Kilimo Company limited at Eldoret branch from august 2013 to April 2014 as a business development officer. Mind the title again; he previously worked at Eco-Bank Kenya Limited Eldoret branch, Regions Group College International, at Equity Bank as a direct sales agent, a bursar and as a graduate trainee respectively. When it came to his net worth that is where the concern is. The nominee informed the committee that net worth ranges from ksh.500, 000 to ksh.1.2 million. For such a person that has worked in all these places Mr. Speaker with all these titles, then when it came to his net worth, it is 500000 to 1.2 million. Unless this guy, Mr. Kipngeno Mutai was volunteering in some other work that he was working, because when he was talking about entrepreneurship or enterprise leader, he should lead by example. This means, he is either extravagant or he was volunteering. Otherwise I support the motion Mr. Speaker. Thank you very much.

The Speaker (Hon. Dominic Rono): Thank you, the Honorable Gilbert Ngetich!

I also want to congratulate the committee for making a body today which is constitutional, I can see a person with disability, a lady, a youth this is a first in Kericho County constitutional body where we have every person in. Starting with because even the one we are sitting on we don't have a person with disability in our Assembly, but anyway we are forging ahead and I know in future we are going to consider this. I take this opportunity that let us pass this report for this people to be in the office. Recently Mr. Speaker I had a group of 700 women who came up in my ward and they have Ksh. 2 million in their account and am seeing these people are ready. I can see a lady called Rero who can actually visit them and train them and let that group operate in my ward and other wards. So as we progress we actually want to see our people perform by making them to have funds through this micro-finance operating. Thank you Mr. Speaker for this opportunity.

Hon Alex Bett: Thank you Chair for this opportunity I will start with part two that part two of this Bill on transportation permit of tea and coffee be amended by deleting the figures 5,000, 7,000 and 10,000 and replace with the figures 4,000, 5400 and 8,000 this were some of the recommendation that were proposed during public participation on the pickups transporting tea and coffee that you can find them on page 12 of this Bill if you open page 12, it talks about the charges that are usually imposed on the pickups, canter and lorries so the members of the public proposed that the figures were a bit high so they proposed that the figures should come down to slightly from 5,000 to 4,000,7,000 to 5,400 and from 10,000 to 8,000 when it comes also to transportation of coffee, initially the pickups were 3,000, 5,400 and 7,000 for pickup, canter and lorries respectively. But remember that coffee is a one season industry so it was of the view of the members of the public that the figures were high on higher side and recommended that it should be brought down to 2,000, 4,000 and 6,000 respectively that is for pickup 2,000, canter 4,000 and lorry 6,000.

That you can find them on page 12 of this Bill on the financial Bill. That is on page 12; it talks about the charges that are usually imposed on pick-ups, canters and Lorries. So the members of the public opposed that the figures were a bit high so they proposed that the figures should come down slightly from 5000 to 4000, from 7000 to 5400 and from 10000 to 8000. When it comes also to transportation of the coffee, initially the figures were 3000, 5400 and 7000, for pick-up, canters and Lorries respectively. But remember that coffee is a one season industry and so it was on the view of the members of the public that these figures were higher and they recommended that it's been brought down to 2000, 4000 and 6000 respectively that for pick-up 2000, canter 4000 and lorries 6000.

For part two under Agriculture, Livestock and Fisheries in the category landing fee be amended by deleting the word per cow in the second column and be replaced by the word per head that is in page 10. When you go to page ten of the Bill. I think that is more of an English amendment

because when you talk about cows ,it is not actually specific but when you talk about per head, that points to numbers so that was the correction of the English part of the Bill.

Next is part two under Agriculture, Livestock and Fisheries in the category sheep, goat be amended by adding the word per head in the second column. It is also like the previous one. When we talk about sheep and goats. I think that can point into a group of sheep or a group of goats but to be specific, we added the word per head so that it can be counted.

Next, that is part two under Agriculture, Livestock and Fisheries in the category hides,...and skin be amended by deleting the word one and replacing with the word consignment. I think it was of the view that when we talk about hides and skin, it was not easy to quantify. So the people during public participation felt that these be grouped to consignment as it arrive. It's counted as one consignment. So we amended the word hides and skin by deleting the word one and be replaced by consignment. That can be shown by the annexure that is attached report.

That part two under Agriculture, Livestock and Fisheries in the category, commercial coffee millers' license less than 3000 metric tons be amended by deleting the figures 50000 in column 3 and 6 and replacing it with figures 10000 respectively. That was supposed to be 50000 but it is replaced by 10000 and it is in the annexure.

Finally that part two under Agriculture, Livestock and Fisheries be amended by introducing a late fee of 10 % of licenses of the fee payable. Initially there was no indication of how it will be charged in case somebody comes paying the licenses fee even after the due date. So there was no indication and so initially people were still paying the original figures. So to make it more effective, a late fee was introduced of 10 % and so that was the introduction. Thank you.
