**The Speaker (Hon. Dominic Rono):** Let's Proceed

**NOTICE OF MOTION**

**The Speaker (Hon. Dominic Rono):** Well we have a notice from Honorable Haron Rotich.

**Hon. Haron Rotich (Member for Seretut/ Cheptororiet Ward):** Thank you very much Mr. Speaker, I want to table a motion on behalf of Chairperson Health Services Committee.

Aware that, health services is one of the devolved functions as stipulated in the fourth schedule, part 2 of the Constitution of Kenya 2010.

Further aware that the department issued a tender advertisement dated 23<sup>rd</sup> September 2021 on various projects to be carried out in the wards for the financial year 2021 /2022.

Noting that this House approved a budget for programs to be executed in the financial year.

Concerned that the department advertised for proposed construction of placenta pit and two door latrines at Chepkosilen dispensary and proposed renovation of staff house at Seretut dispensary and proposed finishing and installation of shelves, electricity and tank at Kipsolu dispensary contrary to the budgeted Ksh. 2.2 million for Seretut/Cheptororiet ward.

I therefore urge this honorable house to resolve that the tender advertisement be suspended until the County Executive Committee Member in charge of health appear before the budget and Appropriation Committee within seven days on a date to be communicated after the passage of this motion to shed light on how the department will appropriate the budgeted money allocated for the projects in the wards.

**The Speaker (Hon. Dominic Rono):** Next order!

### **STATEMENTS**

**The Speaker (Hon. Dominic Rono):** I can see we have two statements one by Hon. Philip Rono and another one by Hon. Bernard Mutai.

**Hon. Philip Rono (Member for Kamasian Ward):** Thank you very much Mr. Speaker for the opportunity.

Aware that, the County Public Service Board is responsible for appointing positions in the department of Finance and Public Service Management.

Noting that this House approved a budget for recruitment of staff to the Finance Department in the financial year 2021/2022.

Concerned that the department advertised for positions internally contrary to section 66 of the County Government Act 2012 which states that; if a public office is to filled, the County Public Service Board shall invite through advertisement and other modes of communication so as to reach as wide population of potential applicants as possible and especially persons who for any reasons have been or may be disadvantaged.

I therefore urge this honorable House to resolve that;

1. The internal advertisement for various positions in the department of Finance and Public services management by the public service management be suspended.

The County Public Service Board members and the County Executive Committee Member in charge of Public Service Management appear before the committee of the Whole House within seven days from the passage of this motion on a date to be communicated to shed light on the said issues.

**Hon. Hezron Ngetich (Member Chilchilla Ward, Majority Leader):** The Finance Department had proposed to recruit 84 but we saw it fit if we add some more funds so that we recruit 90 and we were intending we do so in projection that the County Public Service Board will employ our youth equitably across our wards. Apart from the revenue clerks, we appropriated funds for the recruitment of enforcement officers. Remember few years ago we had trained some youths in Chebwagan and some were absorbed and some were not so we had appropriated again some funds so that those youths can be confirmed and some be absorbed on contract basis. In addition to that there were senior officers in the finance department like procurement and economists' officers who had senior managerial positions in the department. Again we appropriated funds for the recruitment of 200 ECDE teachers. Apart from that we allocated funds for the recruitment of ECDE teachers and salary increment of all the ECDE teachers.

We also appropriated over Ksh. 100 million for confirmation of health officers to permanent and pensionable terms and after doing so we had good faith and passed the budget unanimously without any opposition, and the mandate of the executive was to implement the budget as per the recommendations and the approval of the house. Surprisingly when they did the advertisement instead of doing it openly so that it cannot be discriminatory they did their own things by advertising these positions internally with aim of recruiting their own colleagues and children. We saw it fit that we pass these motion to be resolved by suspending all the internal adverts. So that those responsible come to face the committee of the Whole House and answer some

questions concerning the same because the County Public Service Board as per the County Service Act of 2012, they are supposed to do any work in consultation with the County Assembly through the Committee of Labor, but surprisingly the Chairperson and the Vice are not aware because the County Public Service Board did their own things without any consultation. So I urge this honorable House to support this motion and resolve that internal advertisement of various positions in the Finance Department by Public Service Management be suspended and the County Public Service Board members and County Executive Committee Member in charge of Public Service Management appear before the committee of the Whole House within seven days from the passage of this motion on the date to be communicated to shed light on the same issues. I then urge this Honorable House to support this motion unanimously and call those responsible to come and shed light on how they should do their work. It is not the first time the County Public Service Board is disrespecting this House. There are two incidences which the County Public Service Board has disrespected this House. If we allow them to continue with the same trend we will find them doing their own things. We need to show direction to those members. I beg to end there and I call upon Honorable Alex Bett member representing people of Litein ward to come and second this motion, thank you.

**Hon. Alex Bett (Member for Litein Ward):** Thank you Hon. Speaker for giving me the opportunity to support this very important motion by the Majority Leader, I stand also this afternoon to be one of those members counted to stand against this impunity from the Service Board and I must attest that this is not the first time as clearly put by the Majority Leader, that this County Public Service Board is trying to out win us. I remember that last time, am one of the people who were affected and had complained on the way they recruited staff. Unfortunately these people are very cunning; as soon as they finished the recruitment they switched off their phones and said they were on leave. This time round I think it has come at the right time; we are not going to wait for someone to do impunity and in the name of going on leave has been a problem. This should serve as a warning to some of these people whom we did a lot of work vetting them and bestowing them in these very important offices and they should remember that they are in those offices to serve that common citizen by advertising some of the posts internally

and by doing these they are locking out many of the youths who could be employed. More so we have our youth who were trained in Chebwagan and we had budgeted funds so that slowly by slowly we employ these group of young people but unfortunately this is almost the end of our term and this motion has come at the right time and I urge this honorable House to stand firm and say no to what the Public Service Board is trying to bring to us. I stand to fully support this motion, thank you.

**The Speaker (Hon. Dominic Rono):** Honorable William Soi!

**Hon. William Soi (Member for Chemosot Ward):** Thank you so much Honorable Speaker for recognizing the people of Chemosot. I stand to support this motion which has been brought by our able Majority Leader; really the people are very cunning even the able Deputy Chairperson Labor is in the dark end in this. So I support this motion like yesterday. Thank you.

**Hon. Anthony Rutto (Member for Kipkelion Ward):** Thank you Mr. Speaker for giving me this opportunity so that I can contribute to this very important motion. I also stand here to support the suspension of internal recruitment in the said departments. First before I continue, I want to thank the committee of the Whole House headed by our able Majority Leader for coming up with this very important motion. I also stand here as the Chair of Labor, Governance and Social Welfare and I want to shame the devil that we were never consulted on the same, number two as the budget committee we had appropriated funds for confirmation of 150 Chebwagan youths but unfortunately when we look at the advert 145 are supposed to be confirmed and I was wondering the whereabouts of the other five because we had recruited 150. I tried to ask the whereabouts of the other five and I was told that they were suspended. So I want to support this motion because we want to know the fate of the five Chebwagan youth who were suspended. We had also appropriated funds for recruitment of the 200 ECDE teachers which am told that the idea has been chafed. So I want to support this motion so that at the end of the day the public

service management and the department of education can be able to tell us about the recruitment of ECDE teachers.

We had also appropriated funds for recruitment of further 150 Chebwagan boys and girls. I want to support the suspension of internal recruitment so that at the end of the day we can be able to have time to deliberate on the same so that in future if anything is going to be done we will be in agreement with the Executive. So I stand here to support the motion. Thank you so much.

**The Speaker (Hon. Dominic Rono):** Thank you. Honourable members I see that we still have a long issue in the order paper.

### **MOTION**

**The Speaker (Hon. Dominic Rono):** Hon. Haron Rotich!

**Hon. Haron Rotich (Member for Seretut/Cheptororiet ward):** Thank you very much Mr. Speaker.

Aware that, health services is one of the devolved functions as stipulated in the fourth schedule, part 2 of the Constitution of Kenya 2010;

Further Aware that the department issued a tender advertisement dated 23<sup>rd</sup> September 2021 on various projects to be carried out in the wards for the financial year 2021/2022.

Noting that this house approved a budget for programmes to be executed in the said financial year.

Concerned that the department advertised for proposed construction of placenta pit and two door latrine at Chepkosilen dispensary proposed renovation of staff house at Seretut dispensary and

proposed finishing and installation of shelves, electricity and tank at Kipsolu dispensary contrary to the budgeted 2.2 million for Seretut/Cheptororiet ward.

I therefore urge this honourable House to resolve that the tender advertisement be suspended until the County Executive Committee Member in charge of health appear before the Budget and Appropriation Committee within seven days on a date to be communicated after the passage of this motion to shed light on how the department will appropriate the budgeted money allocated for the project in the wards.

I also want to give an input on the same that according to the advert that was tendered, the other day; I noted that on the issue of my ward precisely the one that is noted very clear that is called Seretut dispensary renovation house was actually done the other year. I was also shocked that there was no consultation basing on the programme that we did when we were in budget committee. We gave Ksh. 1.5 million and the house is complete yet they are advertising the same tender of accomplishing the same work that was done initially. That one prompted me and among other members that they were never consulted according to when we were doing budget and appropriation committee, we consulted widely and we gave out the programmes as per the attached schedule per ward in the whole county. I want to say that the other wards were actually given part of the money that you wonder there had no budget programmes but then they also gave out works belonging to those wards. I am requesting that let us follow the budget; this one will lead to the loss of money belonging to the residents of Kericho County. I want to request honourable member from Kipchebor to come and second the motion.

**The Speaker (Hon. Dominic Rono):** Honourable Erick Bett!

**Hon. Eric Bett (Member for Kipchebor Ward):** Thank you honourable Speaker for giving me this chance to support the motion by honourable Haron Rotich. The reason why I support this motion is because I will pass the budget for this financial year 2021-2022 by this honourable House and we had a schedule of all the wards which allocated money for development in health department and once the department of health tendered some works, the list that is available in

public domain is 59 tenders. Actually I was counted before coming in. Each of them has a description. Just to support the motion, first and foremost we appropriated Ksh. 51.6 million shillings in the budget for development and health department and after that allocation, we gave a schedule of all the wards so what honourable mover of the motion has done is to give an example of just one ward where he comes from whereby the allocation has not been done as per the schedule. If each member was to speak here am sure they would have had also different issues to rise in terms of the allocations. So what the department needs to give us is to give us the costing of the projects they have tendered which is 59 tenders because we need to be sure that what they are tendering is not beyond what is appropriated in the budget that we passed recently. I support because of that, number two is also on the schedule. I remember very well that there are three wards which did not allocate money for health and I want to be proud to say that am one of the members who never got the money. If you check schedule, it is Kipchebor ward zero, Kamasian ward zero and Kapkugerwet ward zero and the good thing is that those members are here. Even if you look at the tender document you realize that some of those wards mentioned have benefited from this budget allocation from this tenders that have been issued so that alone is enough to say this process was done without looking at due process of the County Assembly. That tells you that the county executive might be implementing projects without looking at the budget that this honourable house has passed and so this should be a wakeup call to tell them that this house must be respected and they must follow any recommendation or schedule given thereof. Therefore I fully second this motion. Thank you.

**The Speaker (Hon. Dominic Rono):** Thank you.

**The Speaker (Hon. Dominic Rono):** Philip Rono!

**Hon. Philip Rono (Member for Kamasian Ward):** Thank you very much Mr. Speaker for the opportunity once again. I just rose to support the motion on the said issues concerning the department of health; it is so criminal to do things that are actually against the budget. I know



immediately we pass the budget it becomes a law after the Governor signs the same and it is now criminal because those wards, the schedules you see we normally sacrifice from other departments to allocate money to a different department and if you find you are allocating very good money and you later on realise that actually the same people from the department of health have not even factored in your ward in as far as wards of tender is concerned and some other wards are actually benefiting that do not even have the budget on the same. I think this is criminal and the same members of the executive department of health actually should appear before the committee and may be the procurement department of the same department should also come so that we discuss how they normally plot the tender without considering the budget's provision. Thank you very much and I want to thank honourable Haron for coming up with the same. This will now clear the issues that have been affecting us. Thank you.

**The Speaker (Hon. Dominic Rono):** Nancy Kimetto.

**Hon. Nancy Kimetto (Member for Tebesonik ward):** Thank you honourable Speaker for giving me this chance also to support the motion. In my ward there is a dispensary which I was given to construct/ renovate and yet I renovated it in the year 2019/2020. I was shocked because one; when I was allocating this money I had some dispensaries which are really in pathetic positions what will my people see or what will be the impact to the other dispensaries, the users of the other dispensaries if I go and renovate a dispensary which I renovated one year ago. This is impunity of the highest order and as an Assembly we are revoking this advert so that we can be given the right advert. Thank you.

**The Speaker (Hon. Dominic Rono):** Thank you. Gilbert Ngetich.

**Hon. Gilbert Ngetich ( Member for Kisiara Ward) :** Thank you Mr. Speaker for giving me this opportunity to support this particular motion made by honourable Rotich pertaining this advert which was made which was really not fair and it was not really what we decided to have. Another example is my ward whereby I was given a toilet instead of completion of a particular dispensary. I didn't request for any toilet because a toilet exist so when I really saw an

advertisement or a tender advertisement requiring a new building of a toilet it was really uncalled for. I am coming to realize although we are late that whatever we do pass in this particular Assembly is not actually to be implemented by the Executive. If it means that we sit as the committee of the Whole House for things to be implemented then that's the direction we are heading as we approach the end of our term because we saw changes after sitting in Nakuru the other time. We will actually go for another meeting and sit as committee of the Whole House and we will have things done the way we really expect because if the department can wake up and decide to do anything pertaining my ward it means I will find them building a poultry house in which I didn't mention in my budget. My big request to honorable members is that we unify ourselves and we make our forces strong so that we may conquer the challenges we are facing from the department. When I called pertaining the toilet I was told that they saw the toilet as necessary, my question is, who saw it on my behalf yet I am the area Member of the County Assembly from the particular ward? Thank you I support this particular motion and we are going that direction just to make and bring sanity in the particular department. Thank you.

**The Speaker (Hon. Dominic Rono):** Thank you, honorable Collins Biegon!

**Hon. Collins Biegon (Member for Kapkugerwet Ward):** Thank you Mr. Speaker. I also rise to support this motion by the honorable from Seretut. I think there has been a problem with the department of health. We've had a lot of issues and I think the Chairman is here also, we have heard news that the CEC had been moved to education is back and I hope the sanity is going to come back to this department. There is a problem with this particular issue of having projects done without properly consulting the representative of the people in these areas because by the time we sit in the budget committee we always make sure that the money we allocate as per our schedules goes to specific projects that are a priority in our wards. That is the reason why we sit in this budget committee. You will find that some areas like my area would have more money on tea buying centers or the roads department or any other department depending on the priority as per the CIDP that we pass in this house as per the ADP that we pass in this house. For example even I can use the department of agriculture I have about 2.5 million in Kapkugerwet that is to

build the last tea buying center that is not properly built, a wooden one. We want to have a permanent structure there. I allocated Ksh. 2.5 million for that specific purpose in accordance to the priorities in my ward. So for somebody else to go and sit down and reallocate the money to other projects that are not priority to my ward then that's unacceptable. I support this and I want to encourage the Chairman and the members of the committee that now that the CEC is back we want to see that all those issues we passed, issues of medicine in the hospitals, issues of such kind of developments in our wards that there should be proper consultation with the representatives of the people who are the MCAs so that we find that the development agenda in our wards as promised during our campaigns the other time is sufficiently met. So that before we go for reelection or go back to the people to request for another mandate then we would have fulfilled the promise that we promised at some point otherwise if tenders are being floated without proper consultation then we are going the wrong direction. This should be an action that should send a signal to all the other departments that as they do their procurements plans they should consider the ADP so that we give priority projects. All the departments should consider that and should also liaise with the MCAs to do that. Thank you.

**The Speaker (Hon. Dominic Rono):** Thank you. Alex you had a proposal on the report but I still want more from members to support, my apologies for that. Yes Honorable Alfred Cheruiyot!

**Hon. Alfred Cheruiyot (Member for Chepseon Ward):** Thank you Mr. Speaker for giving me an opportunity so that I may also contribute to this motion that was raised by honorable Haron Rotich. I stand to support the motion, because I am one of the honorable members who were affected by this advert. In the last budget which we did which we are supposed to be implementing right now I had budgeted after sacrificing from different departments. I had allocated Ksh. 2.7million in this department of health. I had a health center in a place called Kapkaren which was constructed and had to be completed. So when I was removing money from other places to put in the department of health my intention and the intention of the people that I represent was that that dispensary may be completed so that it starts serving the people of that

place. Unfortunately when the advert came out I am one of the people who were given an advert in the dispensary that had been renovated recently and again money is put in the same dispensary for renovation. It's very interesting how people work I think they are out of touch with the realities on the ground. You can imagine most of the things that I was given here is water tanks and renovations and also a latrine. If you look at the budget that I am supposed to spend here it's not equal to the money that I allocated. I stand here to support that this advert is cancelled with immediate effect and again if possible to come and appear before the budget committee so that once and for all this kind of anomalies may be stamped out. They should understand that most of the things they do should be done in consultation with this Assembly. Unfortunately this time round we just came to realize that they have advertised things without even asking us. I stand to support this motion. Thank you.

**The Chairman (Hon. Evans Kibet, Member for Cheboin Ward):** Thank you, welcome honorable members to the committee of the Whole House. We proceed I believe everyone has got this report.

**CLAUSE 6**

THAT, Clause 6 sub Clause 1 be amended by deleting the word ‘appoint’ after the word “and” replacing with the word ‘recruit’.

**The Chairman (Hon. Evans Kibet, Member for Cheboin Ward):** Chairman health step forward!

**Hon. Dennis Kirui (Member Kimugul /Kedowa Ward, Chairman Health Committee):**

Thank you very much honorable Chair, Clause 6 reads; the County Public Service Board upon the request of the County Executive Committee Member may establish offices and appoint, so the ward to be replaced is “appoint” to be replaced by the ward ‘recruit’ so that it can read the County Public Service Board upon the request of the County Executive Committee Member may establish offices and recruit such officers under the department in accordance with the county governments for implementation of this act. Thank you chair.

**The Chairman (Hon. Evans Kibet, Member for Cheboin Ward):** Thank you.

Dennis Kirui (Member for Kimugul /Kedowa Ward, Chairman Health Committee):** Thank you very much Chair, Clause 11 had clauses to ‘g’ so we are adding ‘h’ that is, the County Executive Committee Member shall, while appointing the members of the committee, ensure gender equity representation of persons living with disability, youth and marginalized groups. That was an addition it was not there chair thank you.
