I therefore urge this honorable house to resolve that;

- 1. The internal advertisement for various positions in the department of finance and public services management by the Public Service Management be suspended.
- The County Public Service Board members and the County Executive Committee Member in charge of public service management appear before the committee of the Whole House within 7 days from the passage of this motion on a date to be communicated to shed light on the said issues. Thank you.
