**THE KERICHO COUNTY APPROPRIATION BILL 2020  
(COMMITTEE OF THE WHOLE HOUSE)**

*(The Speaker leaves the Chair)*

*(The Chairman takes the Chair)*

**The Chairman (Hon. Josphat Rutto):** Welcome honorable members to the Committee of the Whole House so that we can make some amendments to The Kericho County Appropriation Bill 2020.

**CLAUSE 1**

That Clause 1 be amended by deleting the figures ‘‘8,891,766,093’’ and substituting them with the figures ‘8,851,766,093’

**Hon. Albert Kipkoech (Chairman Budget and Appropriation Committee):** Thank you Chairman, honorable members if you have the Bill you realize that Clause 1 from the Bill there is a figure of 8,891,766,093 Shillings so we are deleting this figures by substituting it with 8,851,766,093 because the department of roads declared unspent by 40 Million which was not

the actual figure and the other day they decided to reduce in by that amount so the reduction will affect the entire figure by this 40 Million. So that is the only request that we are correcting as per what the department declared. Of course if you can add 8,851,766,093 to 40 Million it will come to that figure which is on the Bill, thank you.

**The Chairman (Hon. Josphat Rutto):** Hon. Cheruiyot Bett!

**Hon. Cheruiyot Bett:** Thank you Mr. Chair for giving me this opportunity, now that the debate is abit relaxed, I just wanted to comment on the name that was committed to Committee on Appointment. You know we did vet the CEC in charge of ICT and as you know that the rules are relaxed, that is an illegality.

**The Chairman (Hon. Josphat Rutto):** Honorable Cheruiyot Bett you are out of order!We can discuss that one later on when we come to committee.

**Hon. Cheruiyot Bett:**You also know that even the Speaker communicatedan illegality!

**The Chairman (Hon. Josphat Rutto):** You are out of order Honorable Cheruiyot Bett!

**Hon. Cheruiyot Bett:**The Governor istesting our patience Mr. Chairman!

**The Chairman (Hon. Josphat Rutto):** Order!

**Hon. Cheruiyot Bett:** Otherwise for the amendment, the amendment is good and you know we are amending because of those changes the Committee on Roads has declared the exact money that is unspent. Otherwise we cannot sit here as said we may not want someone who tastes our patience that is an illegality thank you.

*That Clause 2 be amended by deleting the words ‘**Eight Billion Eight Hundred and Ninety One Million, Seven Hundred and Sixty Six Thousand and Ninety Three**’ and substituting it with the following words ‘**Eight Billion Eight Hundred and Fifty One Million, Seven Hundred and Sixty Six Thousand and Ninety Three**’*

**The Chairman (Hon. Josphat Rutto):** Chairman!

**Hon. Albert Kipkoech (Chairman Budget and Appropriation Committee):** Thank you Chairman in that clause we are correcting as per amendment and we are correcting it in words because the bolded words saying Eight Billion Eight Hundred and Ninety One Million, and we are deleting the word Ninety One to read Fifty One thank you.

Albert Kipkoech (Chairman Budget and Appropriation Committee):** The first amendment honorable members refers to Bill page two development expenditure and if you can read that code, you will realize that this is the department of roads and as I said earlier the department of roads over declared the unspent by 40 million. So they are now correcting it by reducing that figure that is there by 40 million. So you will realize that in the first place, it was 1.295 Billion and now they are reducing by 40 million to be 1.255 Billion and at the same time if that amendment is effected automatically it affects the class subtotal by the same figure. If you can see also D33501100 the class subtotal will be affected by the same figure that is 40 million. i.e. so it will reduce from 4,192,001,436 to 4,152,001,436’ and at the same time the grand total will reduce by the same figure to ‘8,851,766,093’ thank you Chairman.
