The Deputy Speaker (Hon. Josphat Rutto): Chairperson may be you can start from the recommendation of the committee.

Hon. Ann Cherono: Page five 2.0.

The Deputy Speaker (Hon. Josphat Rutto): Yes page six 3.0 committee observation.

Hon. Ann Cherono: No, let me turn you back to 2.0 Page five.

The Deputy Speaker (Hon. Josphat Rutto): It's is okay.

Hon. Ann Cherono: Thank you Mr. Speaker. Amendment to the Public Finance Management (Kericho County Assembly Members Car Loan Scheme) Fund Regulation 2014 section 116 of the Public Finance and Management Act 2012. The County Executive Committee Member in charge of Finance and Economic Planning may make regulation regarding to the establishment of funds. In order of the County Executive Committee member in charge of Finance and Economic Planning to comply with the Salaries and Remuneration Commission circular on car loans of state and public officers of County Government. Amendments on the Regulations on the Kericho County Assembly Members Car Loan Regulation were necessary.

The Committee observed the following:

- That section 116 of the Public Finance and Management Act 2012 provides for the scope of the Executive Member's powers to make regulations regarding establishment of the funds.
- 2. The Public Finance Management (Kericho County Assembly Members Car Loan Scheme) Fund Regulation 2014 is amended by the County Executive Committee Member in charge of Finance and Economic Planning so as to comply with the circular by the Salaries and Remuneration Commission which converted the car loan to car grant.

In view of committee recommendations and observations, and pursuant to County Assembly's Standing Order 205, the Committee recommends that The Public Finance Management (Kericho County Assembly Members Car Loan Scheme Fund) Regulations, 2014 in the Regulations referred to as 'the Principal Regulations' are amended as follows;

1. Citation

The words 'and grant' be inserted immediately after the word 'loan' Regulation 2

2. On the definition of Committee, the words 'and grant' be inserted immediately after the word 'loan'

3. On the definition of fund, the words 'and grant' be inserted immediately after the word 'loan'. I think you're seeing there's an attached document which shows that the word 'and grant' be replaced with the word loan.

4. After the definition of fund, the following new definition be inserted;

'Grant' means the Kericho County Assembly grant as contained in the circular No. SRC/TS/CIG/3/

Hon. Ann Cherono: Number three. On the definition of fund, the words 'and grants' be inserted immediately after the word 'loan';

Number four (4), after the definition of 'Fund 'the following new definition be inserted;

Grants means the Kericho County Assembly grant as contained in the circular NO. SRC/TS/COG? 3/61/48 Vol II (113) issued by the Salaries and Remuneration Commission dated 9th February 2021.

Regulation three be amended by inserting the words 'and grants' immediately after the word 'loan.'

Regulation four (4) be amended by inserting the words 'and grants 'be inserted immediately after the word 'loan.'

Regulation six (6) paragraph one (1) be amended by inserting the words 'and grants 'be inserted immediately after the words 'loan'

Regulation 6 paragraph 5 be amended by inserting the words 'and grants 'immediately after the words 'loan'
