**COMMUNICATION FROM THE CHAIR**

**The Speaker (Hon. Dominic Rono):** Honorable members we have received a Bill which is Kericho County Health Services Bill of 2021. This Bill is therefore committed to the Committee on Health for purposes of them looking at it and coming up with comments for purposes of being tabled in the House.

We have also received a memorandum from the Governor on the Kericho County Urban Areas Management Bill of 2021. As you may be aware we had dealt with this Bill but the Governor has sent back the bill un assented with a memorandum on issues that he thinks should be considered by the committee. I recommit this memorandum and the Bill back to the committee on Lands, Housing and Physical Planning.

We have also received a memorandum on the Kericho County Regularization of Development Bill 2021. This is the Bill that we had dealt with in the House; the Governor has sent back the Bill with a memorandum on issues he thinks should be looked into. I therefore recommit the memorandum and the Bill to the Committee on Lands, Housing and Physical Planning for purposes of consideration of memorandum.

We have also received communication from the Governor with respect to the Kericho County Bursary Committee 2021. This is a letter that he says Kericho County is in the process of disbursing bursaries to needy students within the county. I hereby forward a list of CVs of appointed committee members for your approval, so the bursary committee membership is; Hellen Chepkwony, Anthony Koskei, Andrew Maritim, Henry Kirui, Margaret Chepngetich, Charles Mutai and Peter Ngeno. I therefore commit the CVs to the committee on Education and Child Welfare for purposes of interrogation and preparation of a report for approval and adoption by the House.

I have also received communication from the Governor with respect to Kericho County Alcoholic Drinks Control and Enforcement coordinating Committee which says; please find the nominees for position of enforcement coordinating committee. Also enclosed is a copy of Alcoholic Drinks Control Act, so the names are; Mr. Reuben Too, Miss Winnie Chepkemai, Mr. Andrew Siele and attached to this letter are their CVs for consideration. I commit the CVs and this communication to the committee on Trade and Industrialization for purposes of preparation of a report for possible adoption by the House. Thank you. Next order!
