Section 65 of the County Governments Act requires that County Governments ensure that at least 30 per cent of public positions are filled by people not from the dominant ethnic community in the county. Further, Section 68(c) of the County Governments Amendment Act, 2020 requires the County Public Service Board to prepare and implement a Public Service Employment Equity Plan for the purpose of eliminating ethnic imbalance and implementing the provisions of section 65(1)(e). I wish to seek a statement from the Kericho County Public Service Board on the following:

- d) What long-term measures has the County Public Service Board put in place to achieve the requirements of Section 65 of the County Governments Act?
- e) What is the status of the preparation and implementation of the Kericho County Public Service equity plan?
