THE KERICHO COUNTY SUPPLEMENTARY APPROPRIATIONS BILL, 2025

The Chairperson (Hon. Cheruiyot Bett): Thank you Honourable Members. Let me take this opportunity to welcome you to the Committee of the Whole. I want to request the Clerk to proceed.

(Clause 2)

That, Clause 2 be amended by deleting the words "Kenya Shillings Nine Billion, Seven Hundred and Forty Six Million, Four Hundred and Thirty Nine Thousand, Two Hundred and Thirty Six " and substituting them with the words "Kenya Shilling Nine Billion, Seven Hundred and Fifty Six Million, Nine Hundred and Thirty Nine Thousand, Two Hundred and Thirty Six"

The Chairperson (Hon. Cheruiyot Bett): Chairman, Budget and Appropriations!

Hon. Albert Kipkoech (Member for Soliat Ward and Chairperson Budget and Appropriations Committee): Thank you Chairman. Those changes were as a result of balancing and this affected the County Assembly of Kericho especially development vote and that is the reason you can see an increment of about 10 million. Thank you!

RECURRENT EXPENDITURE

That code number 'R4711' be amended by deleting the figures '880,331,329' and substituting them with the figures '880, 334, 303'

Hon. Albert Kipkoech (Member for Soliat Ward and Chairperson Budget and Appropriations Committee): Thank you Chairman. R4711 is the County Assembly of Kericho and as you can see there is an increment of 3,000 shillings which was as a result of last year's disbursement to the County Assembly. What was supposed to be reimbursed to the Assembly was supposed to be 35, 757, 000 shillings but unfortunately what came was 5, 754, 000 Shillings and that is why it was increased by 3,000 Shillings.

The other one Chair is code number R4722 recurrent under ICT. This was as a result of realignment especially in the line of sports that affected the line by about 500,000 shillings.

The last on is class sub-total which of course after the realignments, the subtotal should add up to the figures in the recurrent expenditure.

The Chairperson (Hon. Cheruiyot Bett): Thank you, Chairman.

Hon. Albert Kipkoech (Member for Soliat Ward and Chairperson Budget and Appropriations Committee): Thank you Chairman. Chairman, D4711 that is, the County Assembly of Kericho, and as I had explained earlier, there was an increment of about 16 million shillings which affected the development part.

On D4713 is the Department of Agriculture and of course there were those realignments on seedlings, chicks and that is the reason why the figure has gone up.

Chairman, D4714 which is the Department of Education is as a result of empowerment programs by most of the members and of course construction of ECDE classes and that is why that figure has gone up by about one million shillings.

The other one is the Department of Health which is D4715 and also there were realignments that brought the figure down.

The other one is D4716 which is the Department of Trade; this one also was affected as a result of the realignments. Chairman in short, all these changes are as a result of realignments at least to make the Schedule work and also for members to get something to take back to their wards and that is the reason why the Development vote was affected that much. Thank you!

The Chairperson (Hon. Cheruiyot Bett): Thank you Chair.

The Speaker (Hon. (Dr.) Patrick Mutai): The Hon. Albert Kipkoech, the mover!

Hon. Albert Kipkoech (Member for Soliat Ward and Chairperson Budget and Appropriations Committee): Thank you Mr. Speaker, Sir. Mr. Speaker, I do request the House to allow that the Kericho County Supplementary Appropriation Bill, 2025 to be read for the Third time. Now Clerk, you can now proceed to read the Long Title of the Bill.

Long Title

The Kericho County Supplementary Appropriation Bill, 2025, a Bill for an Act of the County Assembly of Kericho, to authorise the issue of certain sums of money out of the County Revenue Fund and their application towards the service of the year ending on 30th June, 2025 and to appropriate those sums for certain public services and purposes.

The Speaker (Hon. (Dr.) Patrick Mutai): Okay, thank you so much. Honourable Members, we have come to the conclusion of our Order of Business this afternoon session. Just to remind you that next week we are proceeding to the Legislative Summit.

(Loud consultations)
